

2025 Legislation's Impact on the LGBTQ+ Community




✓ 2024 LEGISLATIVE SESSION

The ACLU is tracking 576 anti-LGBTQ bills in the U.S.

Important lessons:

- Anti-trans bills are being pushed by party leadership and PACs, NOT voters
 - Strategy: emphasize de-prioritization of anti-trans bills in order to serve voters
- Our attention is valuable
 - Anti-trans riders in unrelated bills, large barrages of anti-trans bills, quick hearing and voting timelines: all are designed make it harder to notice anti-trans legislation
 - Strategy: keep paying attention, even when it's hard
- People need something to fight FOR, not just against
 - Strategy: emphasize the future we want, even in the face of negative legislation

2025 Legislative Landscape: States

While many bills in 2024 were defeated, hundreds of bills are already prefiled for 2025 indicating more of the same:

- Attempts to criminalize and ban gender affirming health care
- Preventing trans people from obtaining correct identity documents
- Bans on books and drag performances
- Bans on participating in sports
- Attacks on inclusive school policies surrounding gender identity, bathroom use, and censorsing discussion of LGBTQ+ topics
- Elimination of DEI departments in state institutions

Why does Jewish support for LGBTQ+ rights and nondiscrimination protections matter?

No one should face discrimination because of who they are, who they love, or where they live. But in a majority of states, LGBTQ+ people remain vulnerable to discrimination, and people are really hurting.

So often religion is used as an argument against LGBTQ+ rights and protections and that is why it is so important for us to speak up as Jews and say that it is not despite our religion that we support LGBTQ+ protections but **because** it is a part of our religious values to do what is right.

Jewish organizations, such as synagogues, Hebrew schools, camps, and day schools, are *private religious* institutions. For better or for worse, there are limits to the extent that the government can regulate your programs and policies.

Your Jewish organization might be one of the few places where LGBTQ+ people in your community - especially youth - can exist in an affirming way. Many anti-LGBTQ+ laws that apply to public schools and public spaces do not apply to our Jewish spaces.

Anti-LGBTQ+ legislation can open the door for people to claim that they have a right to express homophobia or transphobia in your Jewish space, or to push back against inclusive programming. The key to combating this pushback is to understand the specifics of laws, and *not overcorrecting* in the name of adhering to them.

LGBTQ+ <u>nondiscrimination</u> is extremely popular

81% of American Jews support LGBTQ+ nondiscrimination

Majority support holds across party lines:

- 89% of Democrats support LGBTQ+ nondiscrimination
- 78% of Independents support LGBTQ+ nondiscrimination
- 59% of Republicans support LGBTQ+ nondiscrimination





The Shivyon Cohort Year

Assess

- Develop a congregational working group of 2-4 individuals on the leadership level
- The working group will be guided through an organizational self-assessment of LGBTQ+-affirming programming, policies, and culture.

Learn

- Participate in Keshet's 2-part virtual Day of Learning cohort launch and connect with other Reconstructing Judaism congregations participating in the cohort
- Develop an organizational Action Plan



The Shivyon Cohort Year

Act

- Implement organizational Action Plan through consultation with Keshet through five coaching calls where organizations will receive individualized support, resources, and problem-solving related to their action plan.
- Participate in two cohort conversations centered on peer workshopping as a congregational cohort

Grow!

- End the year long cohort year with a cohort closing and certificate of completion and digital safe zone sticker
- Become empowered to create sustained change for LGBTQ+ equality by developing independence and confidence to identify ongoing goals



How much does it cost?

Flat fee of \$360 per congregation
